




1. In consideration of the amount aforesaid THE TRUSTEES hereby covenant with THE SETTLOR that they, THE TRUSTEES, will stand and be possessed of and hold the said sum of Rs. 1000/- (Rupees One Thousand only) and all other and future donations, howsoever

and from whomsoever received by THE TRUSTEES with or without any condition thereto attached and all moneys belonging to the trust and all investments for the time being and from time to time representing the whole or part of the same and all other properties movable or immovable which may be received, substituted or added in due execution of the Trust powers and provisions of these presents designated and referred to as the "TRUST FUND" upon Trust for the use and with subject to the powers, provisions, declaration and agreements hereinafter declared, contained or concerning the same.

2. THE TRUSTEES shall stand possessed of and shall hold the said TRUST FUND upon Trust to receive, collect and get in, from time to time the interest and other income and profits thereof and there put in the first place to reimburse themselves or pay and discharge all costs, charges and expenses incurred in or about the collection or for getting in the income of the TRUST FUND or incidental to the administration of any of the trusts or powers of these presents and shall also pay and discharge all other costs, expenses and outgoings, taxes, assessments, dues and duties and other taxes, if any, payable in respect thereof and the cost of meeting the ordinary repairs of any immovable property and subject thereto upon trust, apply and utilize the residue of the said income and/or interest of the TRUST FUND at their discretion to apply the same for the following public charitable objects in India;

3. A) OBJECTS:-

- 14. To establish and equip Reading Rooms, Libraries for the Members & students of the institution and also provide educational equipments and scholarship to the clever students.
- 15. To print and publish books, magazines and pamphlets or other literatures, in the cause of Education.
- 16. To establish, conduct and manage (all Medium e.g. Marathi, Hindi & English) K.G., Child Nursery and child Play Group, Primary and secondary schools, Colleges, professional and technical institutions imparting Primary, per-primary, secondary higher secondary, Graduate and Post Graduate Education in all branches of Arts, Science, Commerce, Agricultural, Law, Vocation, Politics, Literary, Religion, Culture, Fine Arts, Crafts, Journalism, Engineering, Medicines, Information Technology & Physical college such as D.Ed., B.Ed., B.P.Ed., B.P.E., B.T.C., M.D. Management course, D. 5. There shall not be at any time less than 3 and more than 7 Trustees of these presents.

6. The Area of operation of the trust shall be ALL OVER INDIA and shall follow the financial year commencing from 1st April and ending on 31st March of its official accounting year.

6.a) Subject to the provisions of the Bombay Public Trust Act 1950, in case any of THE TRUSTEES for the time being of these presents shall become insolvent or shall be convicted of any criminal offences involving moral turpitude then and in every such case it shall be lawful for the other Trustees to give notice to the Trustee so becoming insolvent or being convicted of any criminal offence involving moral turpitude at his last known place or places of abode in India intimating that he is removed as Trustee of these presents and thereupon such Trustee of these presents shall cease to be the Trustee and such Trustee shall after receipt of such notice whenever called on to do so, do all necessary acts on his part for vesting the said TRUST FUND and/or other property forming part of the said TRUST FUND in the continuing Trustee or Trustees or any such Trustees jointly with new Trustees to be appointed under the provisions in that behalf hereinafter contained.

b) If and so often as THE TRUSTEES hereinabove named or any of them or any future Trustees who may be at any time hereinafter appointed shall resign, die or be removed from the office of the Trustees under the power for that purpose contained in the last preceding clause or go abroad and remaining out of the Republic of India at a time for a continuous period of six months without the leave of the competent Authority, or be desirous of being discharged from or refuse or become unfit or personally or physically incapable to act in the Trust of these presents then and in every such case it shall be lawful for the surviving or continuing Trustee/Trustees for the time being, to appoint a person or persons to be a Trustee or Trustees in the place of the Trustees so resigning, dying or being removed or going and remaining abroad or desirous of being discharged, or refusing or declining or becoming unfit personally or physically or incapable to act as aforesaid, as the case may be, and that on every such appointment the said TRUST FUND shall become vested in the new Trustee or Trustees either jointly with the surviving or continuing Trustee or Trustees or solely as the case may be and every new Trustee or Trustees so appointed shall

have the same powers, authorities and discretions and shall in all respects act as if he or they has/have been originally named as Trustee or Trustees of these presents. Provided however, that subject to the provisions of Clause 4 above, if at any time the surviving or continuing Trustee or Trustees think it necessary and proper to appoint or desirous of appointing any additional Trustee or Trustees, they or he shall be at liberty to do so and then and in that event the provisions set out in the foregoing part of this Clause shall apply mutatis mutandis to such appointment.

7.a) THE TRUSTEES shall appoint one among them as the Managing Trustee who shall also act as a Chairman of the Board of Trustees and shall preside at all meetings of THE TRUSTEES. In the absence of the Chairman, THE TRUSTEES present in the meeting shall elect one among them as the Chairman of the Meeting. For the present THE SETTLOR shall be the Managing Trustee and Chairman of the Board of Trustees so long he desires and continuous to be a Trustee of these presents. The aforesaid trustee shall be the permanent member of trust and can appoint various members including individual.

b) THE TRUSTEES may meet together as many times as they think fit for the dispatch of business and may adjourn and otherwise regulate their meetings and proceedings as they may think fit. TWO Trustees physically present shall form quorum. If there is no quorum within half an hour, the meeting shall be adjourned to some other convenient date. No business shall be transacted in the meeting without required quorum.

c) THE TRUSTEES shall keep or cause to be kept minutes of their proceedings and proper books of accounts and shall get the accounts audited by professional auditors. The Trustees may from time to time open and maintain in the name of the Trust or in their own names current /saving bank or deposit account or accounts with such scheduled bank or banks post office or offices as may decided and may operate on the same all money received thereof for current expenses.

d) A resolution passed without any meeting of THE TRUSTEES and evidenced by writing under the hands of the majority of THE TRUSTEES shall be as valid and effectual as a resolution duly passed at a meeting of THE TRUSTEES held in accordance with the provisions of these presents.

e) In case of any difference of opinion among THE TRUSTEES for the time being in any matter concerning the said Trust including interpretation of these presents, the

power of appointment of Trustees or any other matter or question relating to or arising in the due execution and administration of the Trust hereof, the opinion of the majority and in case of a tie, the decision in accordance with the casting vote of the Chairman shall prevail and binding and conclusive.

8. For the due execution and administration of the Trust of these presents and without prejudice to the generality of any powers hereby or by law conferred on or implied or vested in THE TRUSTEES, and subject to the provisions of the Bombay Public Trusts Act, 1950, the following powers and authorities are hereby expressly conferred on THE TRUSTEES, that is to say;



a. THE TRUSTEES shall have power, in their absolute discretion to accept, donations and any other sum or properties or assets in any form or manner including shares of any company from any person, firm, or company, institution, or funds realized by holding of any exhibitions, shows or other forms of entertainment or drive by publication of souvenirs for the purpose of raising funds and/or collection for the objects and/or purposes set out in Clause 2 hereof on such terms and conditions as may be deemed by them proper, being not inconsistent with the trust and terms thereof, and the amount of such donations or property or assets so accepted and/or collected shall be treated and dealt with as forming part of the Corpus of the TRUST FUND and all the terms, powers, agreements and provisions herein shall apply to the same mutatis mutandis. THE TRUSTEES shall also be entitled to take-over the management of any trusts, or charitable institutions or charities as well as carry out the trusts under any deed of trust or charitable bequests or legacies under any will or testamentary writing, on such terms and conditions, if any, as may be thought fit by them in their absolute discretion provided nevertheless the same are for carrying out public charitable purpose as set out in the preamble and Clause 2 hereof.

- d. To accept deposits with or without interest from the public and or from public institutions and to take loans from banks, other institutions and/or individuals.
- e. To appoint and dismiss and re-appoint, employ servants, clerks, care-takers, managers and others on such salary and on such terms as they think fit.
- f. To grant lease for such period and on such rent and on such terms and conditions (including option to the lessee to purchase) as they may think fit and to accept, surrender of any lease.
- g. To treat, in their absolute discretion any amount howsoever received, as income or capital.
- h. To compromise, amalgamate, compound, refer to arbitration sue for or defend any action, proceedings, difference or demand relating to the Trust and/or the TRUST FUND and/or its income, in such manner as they deem fit and to execute all documents and things expedient for such purposes.
- i. To frame rules, regulations and bye-laws and to repeal, amend or later the same, and to do all such acts, deeds and things as may be necessary for effective administration of the said Trust and for carrying out its objects.

9.a) Subject to the provisions of the Bombay Public Trusts Act, 1950, THE TRUSTEES shall invest and keep invested all the TRUST FUND in their hands, and also the interest thereof, if any, not required, in any Deposit Account with any scheduled bank or banks at such rate as THE TRUSTEES may think fit and/or in any of the securities, Government Undertaking Companies and Investments or any of them into or for other of the same or of a like nature, and to sell any investments at such price and subject to such terms and conditions as THE TRUSTEES may think fit and to execute all deeds and documents necessary for the purpose.

b) The investment of the TRUST FUND or the interest or income thereof or any part thereof shall always be kept in the name of the Trust as far as possible, or in the name of such number of Trustees as may be decided by THE TRUSTEES from time to time and in case of banking account and deposited, as aforesaid, the same shall be dealt with or operated upon, in such manner as may be decided by THE TRUSTEES.





10. The receipt in writing of the Managing Trustee or any two of the Trustees for the time being for any sums or moneys paid, given or transferred to him or them by virtue of these presents or in the execution of any of the trusts or powers of these presents or duly authorized person or employee of the Trust shall be sufficient, for effectual discharge of the same and the persons to whom such receipt shall be respectively given shall not be answerable or accountable for the loss or misapplication or no application thereof or be in any way bound to see to the application of the moneys thereby acknowledge to be received.



11. It shall be lawful for the Trustees in the event of Winding up/Dissolution/Determination of Trust the Trustees in the trust board should have 3/4th clear majority and also subject to the provisions of the Bombay public trust act, 1950 and the Income tax act, 1961 and the Assets remaining on the date of winding-up etc. under no circumstances shall be distributed amongst the Trustees but Public shall be Transferred to and handover by way of donation to the any other Public Charitable Trust or Institution having similar objects and purposes of these presents or such of these as may be directed by Trust Board and subject to provisions contained in Bombay Public Trust Act, 1950 and income Tax Act, 1961.

12. Trust Fund for the benefit of the poor and needy persons for education, medical relief and other charitable purposes. The trust fund shall be applied exclusively for public charitable purpose as per the terms of this Trust deed and subject to such conditions and/or limitations, if any, as may from time to time laid down in the Income Tax Act, 1961 or any other Act governing to tax action of income as will ensure or make the Trust and its and its income eligible for exemption from taxation under the Income Tax Act 1961 or any replacement or re-enactment thereof. For the purpose of these presents, the expression in the "Charitable Purpose" shall have the meaning as is assigned to that expression in the Income Tax Act, 1961 and the Bombay Public Trust Act, 1950 or any statutory modification of reenactment there for the time being in force.

एक से अधिक पैन आबंटित होने की असंभावित स्थिति में इस तथ्य को अपने कर-निर्धारण अधिकारी की जानकारी में अवश्य लायें क्योंकि एक से अधिक पैन रखना या उसका प्रयोग करना कानून के विरुद्ध है तथा इसके लिये 10,000 रुपये तक दंड लगाया जा सकता है।

यदि आपके पैन कार्ड पर मुद्रित विवरण में त्रुटि हो तो उसे आयकर पैन सेवा इकाई के उपर्युक्त पते पर अथवा पैन कार्ड के पीछे दिये गये पते पर सूचित कर सकते हैं।
